7. CLERKS REPORT

To **RECEIVE** the oral report of the Clerk on matters which may be of current interest to Members and which require a formal update, and to **RECEIVE** such correspondence and communication as the Clerk may place before the Council, which at the time of printing the agenda includes the following:

- Brentwood Borough Council are conducting a call for sites their Local Plan was adopted March 2022.
- A large number of tyres were dumped on land adjacent to Stewarts Farm. This was reported to EFDC who have opened and investigative file on the matter. There is also concern that some type of foundations have been dug at the site the Chairman has been advised and will keep an eye on it.
- ECC Conducting a review of its Minerals Waste Plan, extending the plan up to 2040, and after completing a call for sites recently there will be a public consultation on both documents and their associated evidence base in February 2024, which will include the location of the 52 new sites.

- Clerk liaised with EFDC regarding Carol Service which had been cancelled this year, however was then reinstated The Chairman attended.
- Government has extended no referendum principles to Parish and Town Councils
- Xmas tree lighting at Jubilee Green went well, however possibly due to the poor weather numbers were less than last year.
- Hellabys invoice was cancelled, and they are no longer our contracted boiler service company.
- Note formal confirmation from ECC that the VAS sign near Bridge Farm is not managed or maintained by ECC.
- To note that the recent speed survey conducted along the A113 was not part of a Highway Panel Scheme, however is thought to be part of a Road Safety Audit being conducted by ECC. The Clerk has raised a query with ECC to establish who instructed the traffic count (FS-Case-572494967).
- Guidance from company who supplied the English Fir on Jubilee Green advised not to trim the tree back during winter given its condition, hence the reason the tree has not been trimmed.
- The Clerk responded to the relevant consultations as agreed at the November meeting.
- Calar Gas oil delivery to the hall 28th December 2023
- Two parish defibrillators have been registered with The Circuit national database for defibrillators.

9. BUDGET / PRECEPT 2024/2025

Councillors are asked to *CONSIDER* the budget, and subsequently the precept, for 2024/2025. This will be completed on a 'live' basis during the meeting. Councillors are asked to contact the Clerk prior to meeting if they have something specific they would like to be considered. The District Council has asked to be notified of the Precept request by **31st January 2024.**

Councillors are asked to note that for the current year the Parish Council element of the Precept for a band D property is £57.87 (£1.11 a week). The calculation to get to this is the amount the Council request in precept divided by the tax base (no. of houses EFDC are expecting to collect council tax from), which for this current year was as follows: £21,684 / 374.70 = £57.87. The tax base for 2024/2025 has increased to 382.30. If the Parish Council wishes to show a NIL increase in the parish council element of Council tax for next year, the maximum amount the Council can demand of EFDC in terms of precept would be £22,123.70 (£22,123.70 / 382.30 = £57.87).

Councillors will be asked to *CONSIDER* the 2024/2025 budget and precept. Some of the main points for consideration include:

- Possible building works to the hall to replace the asbestos roof and include solar panels
- Continuation of the Speederbot data collection
- Toot Hill Village Hall income and expenditure

- Grant funding awarded to the church
- Grounds maintenance contract
- Any future projects (Cllr Adams suggested purchasing land at Jubilee Green, and purchase of planters for along London Road).

12. EXTENDING 375 BUS SERVICE

On 7th December the Clerk and Cllr Jackson met with Mary Dadd, Ongar Neighbourhood Planning lead, regarding the lack of bus services going through Stanford Rivers. The purpose of the meeting was to see if

there was any way this Council could gather support from residents in Ongar for extending the 375 bus service. During the meeting it was stated there was no particular evidence suggesting a need for public transport towards Romford, and since the meeting we have received feedback on the Neighbourhood Plan questionnaire regarding this. The Clerk and Cllr Jackson will provide an update at the meeting.

13. REQUEST FOR INFORAMTON

Cllr Jackson has received a request for information from a student completing A-Level geography coursework, who has asked if this Council could answer the following questions regarding the socio-economic impact of the delay of the River Roding flood management scheme in the Woodford and Wanstead area, London Borough of Redbridge.

- 1. What has been the social impact of the project delay on you personally and the people you represent? E.g. disruption to travel, loss of property, school closures, impact on households and communities
- 2. What has been the economic impact of the project delay on you personally and the people you represent? E.g. damage to infrastructure, higher insurance costs, lost productivity, cost to the council, reluctance to invest in home or infrastructure improvements
- 3. What has been the mental health impact of the project delay on you personally and the people you represent? E.g. worry/anxiety over flood risk, feelings of helplessness
- 4. Has the council had to implement any flood mitigation measures as a result of the delay? Councillors are asked to **CONSIDER** if they wish to respond to this request.

14. HIGHWAYS / FOOTPATHS

- a) LEPP202047 A113 London Road, Stapleford Tawney, request for traffic calming measures and signage JW Epping Lane / A113, at Validation Stage. No update.
- b) Flooding There are two issues of flooding, the first being that the A113 near Traceys Farm has been flooded at least three times in the last 4 weeks. The second being flooding at a property along London Road / Hare Street (Hare Cottage). With regard to the latter the Clerk has requested Cllr McIvor look into this matter, as it has been ongoing for over 23 years. Cllr McIvor liaised with the resident and the ECC Cabinet Member, and the Clerk has asked for an update. In addition the Clerk has contacted EFDC Drainage Officer asking him to investigate both matters. Councillors are asked to CONSIDER what action they wish to take regarding the following breach points:
 - Hare Street
 - Duck Pond
 - Tracey's Farm
 - Others?

a) Footpath 62, Stanford Rivers

As emailed to Councillors, ECC conducted an informal consultation on the possibility of moving footpath 62. The Parish Council now awaits the formal consultation by ECC on its proposals.

15. TOOT HILL VILLAGE HALL

- a) Solar Panels for Roof Following the grant award of £15,000 via the UK Shared Prosperity Fund to support the purchasing of green, energy efficient infrastructure for Stanford Rivers Village Hall, the Clerk has continued to liaise with a contractor to obtain a quote for the works. The Clerk will provide a further update at the meeting.
- b) Oven Rubber Lining Cllr Tallon advised that a member of the folk club noticed the rubber had come off, and subject to the Parish Council agreeing to the purchase of the rubber he would be happy to fix it free of charge.
- c) Electricity / Lights Following a report that the external bollard lights were not working, along with the external flood lights, a visit from the council's electrician took place on 4th December who resolved the problem. However, since this time the Chairman advised that there was an issue with the timer, and has arranged for its replacement. Cllr Tallon has also advised there are some lights that are out in the main hall.
- d) Lock to Front Door The Clerk was advised in December by a hall hirer that there were problems with the lock on the front door to the hall. The Chairman visited site and arranged for this lock to be fixed,

however it ultimately needed to be fully replaced. The Chairman to provide an update on the current situation with the lock.

- e) Gigaclear the 12 month free internet access period is coming to and end. The Clerk has contacted Gigaclear to renew this free service for another 12 months.
- f) Annual Fire Risk Assessment and Extinguisher service was completed in November.
