It took some time for the previous Charity (which closed) to transfer the funds held for the hall by the Charity to the Parish Council, and this was finally completed on 16th April 2022. The amount received was £12,740.43. In 2021/2022 the Council received a Bursary of £543.75 towards the cost of the Clerk undertaking her CILCA qualification, together with grant funding of £1,135.41 versus £0 in 22/23.

It was noted at the 22/23 Budget meeting that the Clerk had not received a pay rise since joining - thus 8 years. Since this time the Clerk had also passed her CiLCA qualification, and it was agreed to increase her salary to reflect this.

6 All Other Payments	9,876	20,607	10,731	108.66%	YES		In 22/23, the Parish Council spent an additional £6,607.79 on essential works to the Toot Hill Village Hall. This included £680 for repairs to disabled ramp, £1,200 for removal of trees and grounds clearance, £300 for repairs to entrance doors, £456 for decking repairs, £225 for roof gable repairs, £195 for guttering and brick repairs, £318 for internal works, £970 for electrical repair works. In addition, it was discovered that the Gas Tank had a leak, and this resulted in a cost of £709 to both investigate and repair the leak. There were further costs in lost gas as a result of the leak, however this is thought to be around £300. In addition, the Parish Council purchased and planted a Yew Tree at a cost of £2,808. This is in place of purchasing a Christmas Tree each year, and the cost is expected to break even in 5 years, after which time there will be a cost saving. The Council spent £1,277 on legal fees concerning the properties adjacent to the village hall, and works associated with negotiating the release of a covenant on land. In addition, the Parish Council £667.73 on a Queens Jubilee celebration event. Other than some other general fluctuations is budget v spend, these additional costs account for the increase.
